IMPORTANT: A member has 30 calendar days to apply for the use of the Sick Leave Bank. The 30 days will be calculated from the first day the member will lose pay due to the lack of sick leave. In reviewing requests for Bank leave, the Committee will count back 30 calendar days from the date the request is received at the SEIU Local 500 Office and rule ineligible any days requested prior to that date.

These dates are subject to change and should not be viewed as a commitment by the Sick Leave Bank to process a particular request according to a particular schedule. The Committee recommends that you discuss the anticipated scheduling of your request with the administrative staff of the Committee.
